#### Draft Rules

THE NAGALAND SHOPS AND ESTABLISHMENT (FIRST AMENDMENT) RULES, 2024

In exercise of the powers conferred by sub-section (1) of Section 34 of the Nagaland Shops and Establishment Act, 1986, the Government of Nagaland makes the following rules to amend the Nagaland Shops and Establishment Rules, 2014, namely:-

#### 1. Short title and commencement

- (1) These rules may be called, "The Nagaland Shops and Establishment (First Amendment) Rules, 2024."
- (2) They shall come into force from the date of their publication in Nagaland gazette.

#### 2. Amendment of rule 11

After rule 11 of the Nagaland Shops and Establishment Rules, 2014 (hereinafter called the principle rules), the following rule shall be inserted, namely:-

## "11A. Exemption of establishment from registration

All establishments provided for exemption under section 3 of the Nagaland Shops and Establishment Act, 1986 shall be exempted from registration."

#### 3. Amendment of rule 24

After rule 24 of the principle rules, the following rule shall be inserted, namely:-

### "24A. Maternity leave.

In case of a woman worker, maternity leave under the provisions of the Maternity Benefit Act, 1961, shall apply."
